

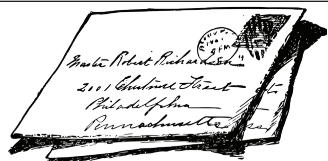

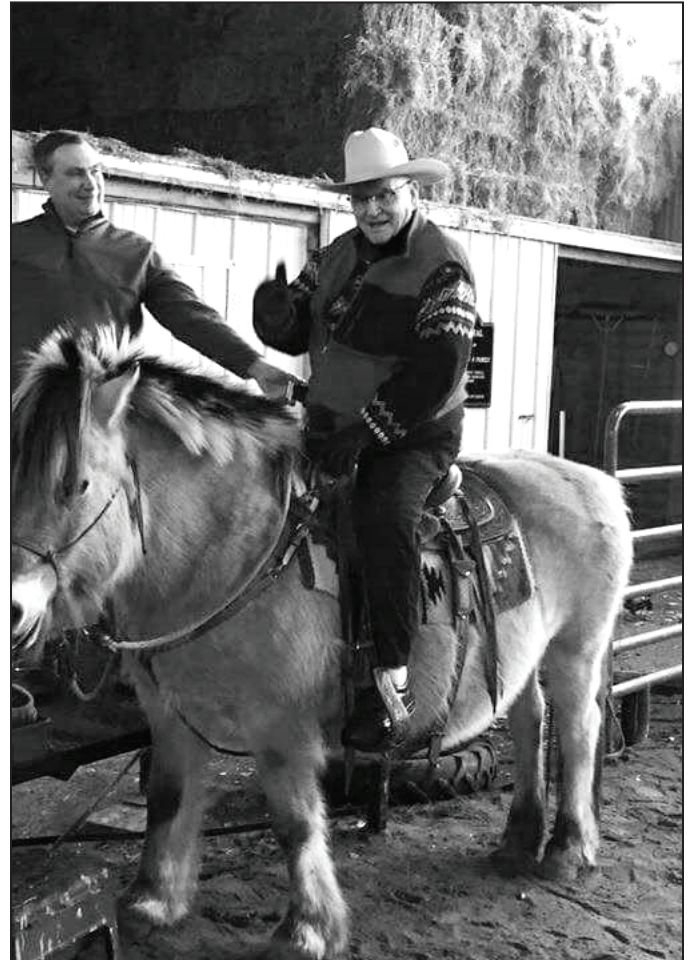

## Durword (D.W.) Duhachek

Durword (D.W.) Duhachek, age 71, of Mission Hill, South Dakota, died on Friday, December 23, 2016 at the Collier Hospice Center in Wheat Ridge, Colorado.

Funeral services were Friday, December 30, 2016 at St. John's Lutheran Church in Yankton, South Dakota with Reverend David Gunderson officiating. The family will receive friends from 5:00 to 7:00 PM, on Thursday, December 29 with a video tribute and time of sharing held at 7:00 PM. Burial will be at the Hillcrest Cemetery in Norfolk, Nebraska at a later date.

Durword (D.W.) Duhachek was born November 18, 1945 in Norfolk, NE to Ralph and Ethel (Tibbles) Duhachek. He was raised on a farm near Meadow Grove, NE and loved all aspects of farming, raising livestock, driving and tinkering with the machinery, and the carefree lifestyle of growing up on the farm. D.W. graduated from Newman Grove High School in Newman Grove, NE in 1965. He then went on to learn body work at Continental Body School in Denver, CO. As an adult, D.W. was involved in the transportation industry, starting with over the road driving then moving into brokerage and dispatch. He specialized in arranging and transporting excess federal property and was also very proud of his ability to engineer the movement of super loads of machinery and power boilers.

In 1981, D.W. met and married Nancy Kai, they combined their families consisting of his three children and her son and added an additional son. The family settled in the Yankton area, where D.W. not only was an outstanding father to his own children but was an outstanding example and mentor to many of his boys' friends as well. D.W. never met a stranger or a person he couldn't talk to. He was a man of many talents and diverse interests. He served on the Town Board of Mission Hill for 13 years and spent many of those years as President of the Board. He belonged to St. John's Lutheran Church, Antique Auto Association, Kiwanis, helped found Tri State Old Iron, was a member of the John Deere Three Cylinder Club and the Menno Power Show. In every organization he was involved in, D.W. served in many capacities as President or a board member, always helping the organization grow and better serve the membership.

D.W. is survived by his wife, Nancy; three sons: Brandon (Jessica) Duhachek, Joe (Crystal) Duhachek and Eric Duhachek; daughter, Jackie White; six grandchildren: Kylie and Logan Duhachek, Madeline Duhachek, Shauna, Ashley, and Hailey White; sister, Miriam (Douglas) Taylor; mother-in-law, Marcella Kai; sister-in-law, Nedra (Jerry) Dickey; many nieces and nephews; and countless friends.

He was inducted into the South Dakota Auctioneers Hall of Fame in 2014.

Rich was blessed to be able to enjoy the things he loved with his family including auction sales, collecting cars, attending Nascar races and watching rodeos.

## Off-road vehicle tax changes

As of July 1, 2016, the sales of off road Vehicles (ATVs, UTVs, dirt bikes, etc...) became subject to motor vehicle excise tax and not sales taxable. This includes casual sales.

The law also requires individuals or companies in the business of selling off road vehicles to have a dealer's license. After July 1, anyone making application for title on an off road vehicle is required to pay the 4% vehicle excise tax and if charged sales tax, they will have to request a refund from the party that charged them the sales tax.

Do you know if your association is aware of this statute change? When these units are sold at an auction, sales tax should not be collected.

Please let me know if you have any questions regarding this and if you are able to relay this information to your members.

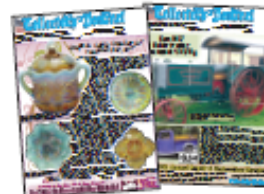
