

We appreciate the SD Association and thank you to those who have given us an opportunity to post your auctions. Let us know if you have any questions as we're here to serve you.



Hello everyone,

I hope all of you are doing well.

I thought I would let all of you know what I had found out about the SD Auctioneer's License Law that had gotten changed on us. Some or all of you may already know this information.

I did not like the answer that was given to us at convention by the lady from the Real Estate Commission. I thought she knew more than she was telling us. I reached out to one of my local legislatures - Senator Al Novstrup from Aberdeen a couple of weeks ago. I've known Al for many years so I felt comfortable reaching out to him. I explained that I was making the call on behalf of myself and not the SDAA. I told him what we were told at the convention by the lady from the Real Estate Commission (I'm sorry I cannot remember her name). Al looked into it and reported back to me right away. I got side tracked and am now getting around to letting all of you know what I was told.

To the right is a two-page report. We are SB 28 (at the bottom of page 1 and top of page 2). As you can see SB28 was not presented by a legislator as we were told. It was presented by Graham Oey (Department of Labor & Regulation) and the Proponent was Melissa Miller (SD Dept of Labor & Regulation also the Executive Director of Real Estate Commission).

Al told me how to look up SB28 and that if I wanted to listen to the actual proceeding, how to do so. The steps are easy. 1) Go online to SD Legislature. 2) On gray bar at top - select Session. 3) Select Archived. 4) Select 2020 Bills. 5) Scroll down to SB28 - there it is. 6) There will be an Eagle off to the side - select that and it will play the entire session for you to listen to. I've done that and listened to all three.

As you can see, Al was on this committee. He asked what it was all about and said it was odd that nobody disputed SB28. I told him that we didn't know about it because if our Association had known, we would have had someone there. I also told him what Ted Petrak said at convention about being contacted, asked his opinion and then told never mind. If you listen to the recording, you can hear both Sponsor and Proponent testify there are no disputes against SB28.

I told him why I felt it was important to have that Auctioneer's Real Estate License - that it is important for people to be able to sell without having to find a broker to work under for two years. I told him that the legislature also changed the license law so that any unlicensed person can auction and ring under as long as they worked under a licensee - but I have not found that bill. Al did remark that he and a lot of legislators do not like smaller businesses being pushed around and he did not seem happy about this bill or how it happened.

He said he is more than happy to present a bill and try to repair what has been done. He said there is no guarantee that the rest of the Legislature will see it his way but he is willing to sponsor a bill to repair the Auctioneers License Law if we would like. I told him that I would reach out to our Executive Board leave it up to you to decide.

I wanted to make sure that our executive board is aware of this

What you decide to do with this information is up to you. I just wanted everyone to know what I was told and have a chance to read and listen to SD28 yourself if you like. If anyone wishes to contact Senator Novstrup, his number is (605) 360-9711.
